### CONDITIONS


1. The official (s) will not claim TA/TP.
2. The seniority on transfer will be fixed in accordance with provisions of Rule-38 of P & T Manual Vol.IV as amended from time to time.
3. The pay of the official (s) will be fixed under FR-22.
4. Re-transfer to their old units will be guided by rules prescribed in the Directorate letter no.141-141/2013-SPB-II dated 17.01.2019.
5. All other terms and conditions as enjoined in Rule-38 of P & T Manual Vol. IV as amended from time to time shall be applicable to them.
6. The official(s) not willing for transfer may intimate his/her/their unwillingness to this office within 10 days of issue of this memo. The Divisional Superintendent of transferee units will intimate the place of posting to the Divisional Superintendent of the transferring units in due course.
7. If any disciplinary/vigilance case is pending/contemplated against the official, the concerned Divisional head should not relieve him/her and report should be sent to this office immediately by concerned Divisional head.
8. Officials, those presently holding tenure post will be eligible to join in the new Division on Rule-38 transfer only after completion of post tenure or termination of tenure whichever is earlier.

One declaration to the effect of acceptance of above conditions should be obtained from the official in triplicate at the time of his/her relief and kept on record.

As per Directorate letter No. X-12/1/2019-SPN-II dated 24.10.2019; relaxation has been extended to reserved community candidates selected against UR vacancies on merit. According to above guidelines, such candidate selected against UR vacancies have been granted relaxation at serial number 12 and 14 on the basis of confirmation received from concerned recruiting units.

As per Directorate letter No. X-12/1/2019-SPN-II dated 30.04.2020, relaxation has been extended to PH candidates at Sl. No.5, 6 & 9 in waiting list of previous year based on length of service.
