The above transfer is subject to the following terms and conditions:

1. That the officials will not claim TA and transit.
2. That their seniority in the new unit on transfer will be fixed in accordance with provisions of Rule - 38 of Postal Manual Vol.IV as amended from time to time.
3. That their pay will be fixed under FR - 22.
4. Their retransfer will be guided by the rules prescribed in Directorate letter no. 141-141/2013-SPB-II dated 17.01.2019 and letter No. X-12/6/2021-SPN-II dated 17.11.2021.
5. That they will have to forgo all claims for confirmation in the old unit even if a permanent vacancy was available because of retrospective permanency of post or for any other reasons for which they were entitled for confirmation in their old unit.
6. That after transfer to new unit they will be eligible for confirmation in the new unit (if not confirmed in the old unit) only according to their position in the gradation list of the new unit.
7. That disciplinary/vigilance case, if any, is pending/ contemplated against the officials, the concerned Divisional/Unit Head should not relieve them and report should be sent to this office immediately by the concerned Authority.
8. All other terms and conditions as enjoined in Rule - 38 of Postal Manual Vol. IV as amended from time to time shall be applicable to them.


