Short Notice inviting e-Tender

Online e-Tender in prescribed format under e-publishing system is invited by the Superintendent of Post Offices, Rourkela Division, Rourkela - 769011 for auction sale of three condemned departmental vehicle lying in the campus of O/o the Postmaster, Rourkela-2 MDG, Rourkela - 769002. The bidders are requested to submit the tender in prescribed format Annexure-I along with earnest money deposit of Rs.3000/-(Rs. Three thousand only) for each vehicle in shape of UCR deposited in any Post Office and one copy of the original UCR must be attached with the tender document. Tender without earnest money deposit will not be considered. The earnest money deposit will be refunded to the unsuccessful bidders after finalization of the tender but no interest will be paid. The bidders can send the bid by Regd. / Speed post or drop the same in the tender box kept in the chamber of the undersigned. The bid complete in all respect should reach this office latest by **31.03.2020 till 1PM**. The tenders will be opened on the next day in the chamber of the undersigned in presence of the bidders or their authorized representatives. The highest rate above the tender amount will be accepted.

The intending bidders can inspect the vehicle during office hours on working days. The bidder whose tender is accepted shall have to deposit the tender amount in full within 7 days from the date of confirmation of their bid failing which earnest money deposit will be forfeited.

The vehicle is to be removed from the site within seven days of depositing the tender amount in full and or orders are passed that effect. Custody and safe guard of the vehicle if not lifted within the stipulated time shall be the responsibility of the bidder and no claim or complaint on this matter shall be entertained. Further on failure to remove the vehicle within the stipulated time, ground rent of 1% of the tender amount shall be charged for each day or part of the day till the vehicle is removed from the site. Where the ground rent so charged exceeds the sale price deposited, the bidder shall cease to have any right on the vehicle and the amount deposited by the bidder shall be adjusted towards ground rent. Separate tolls, implements will not be delivered with the vehicles. The undersigned reserves the right to reject or cancel the tender without assigning reason thereof.
