The Competent Authority is pleased to approve the declaration of result pertaining to Competitive Examination for recruitment to the cadre Postman/Mail Guard from Gramin Dak Sevak (GDS) for the unfilled Limited Departmental Competitive Examination vacancy of Postman/Mail Guard of the year 2022. Written examination in Paper I, II & III was held on 04.09.2022 followed by DEST on 13.11.2022 in accordance with the Directorate instructions contained in Letter No.17-08/2018-SPN-I dated 05.04.2022.

2. The Provisional and Final Answer Keys (Series A, B, C & D) of Paper-I, Paper-II and Paper-III of the above LDCE/Competitive Examination held in Odisha Circle were already circulated to all Unit/Divisional Heads as well as displayed in Odisha Post Website.

3. In pursuance of Directorate instructions contained in Letter No.17-08/2018-SPN-I dated 05.04.2022, the candidates who qualified in both in Paper-I and Paper-II (Combined), Paper-III and Paper-IV (DEST) separately shall be considered for final selection. Accordingly, the Merit List has been prepared only on the basis of total marks secured in combined Paper-I and Paper-II, since Paper-III and Paper-IV (DEST) are qualifying in nature. The result has been compiled taking the scores of Paper-I and Paper-II (combined) as merit and also in accordance with the procedure prescribed vide Directorate Letter No.17-08/2018-SPN-I dated 15.06.2022

The qualifying marks for Postman/Mail Guard as per Directorate letter No.17-08/2018-SPN-I dated 05.04.2022 is mentioned below.


