Part -V

The Committee on Compassionate Engagement (CCE) considered the following Court/CAT cases of the dependents of the deceased GDSs for their engagement on compassionate ground.

(42) The case of the **Ramesh Chandra Mohanta**, S/o Late Maheswar Mohanta, Ex-GDSMC, Betnoti SO under Mayurbhanj Division considered in the CRC held on 24-11-2010 and rejected as the family of the deceased was found not to be in indigent condition.

The applicant has filed OA No. 09/2012 before the Hon'ble CAT, Cuttack Bench, Cuttack against the decision of the CRC.

The Hon'ble Tribunal vide order dated 03.07.2018 has directed to the Respondent to re-open the case and ask the applicant to submit his application in the context of the merit point system and his case should be considered for two more years in the next CRC meeting.

The committee examined the case in the light of the Hon'ble Tribunal vide order dated 03.07.2018 in the CCE meeting held on 11 Jun 2019, 02 Sep 2019 and 18.11.2019 and did not approve the case due to less educational qualification and will not be productive for the department as the applicant is 60 years old.

Again as per the direction of the Hon'ble Tribunal the case was re-examined and **did not recommend** the case due to less educational qualification and will not be productive for the department as the applicant is 60 years old.

(43) The case of **Himanshu Sekhar Biswal**, S/o Jibardhan Biswal, Ex-PA, Gandhi Chowk SO under Kalahandi Division was examined by the committee and found that the case is Departmental case and will be submitted before next CRC meeting scheduled to be held at this office during Apr-Jun 2020. Therefore a time petition may be filed in the Hon'ble CAT requesting for the time of 4 months.


(44) The case for compassionate engagement of **Rajat Kumar Mahanta**, S/o Late Dambarudhar Mahanta, Ex-GDSBPM was considered in the CRC meeting held on 31.01.2017 and rejected as the applicant secured 35 merit points against 36 merit points to be considered the case as "hard and deserving" as per the parameters prescribed in the Directorate letter No. 17-17/2010-GDS/ dated 17.12.2015 (A/5).

Being aggrieved, the applicant filed OA No.646/2019 in the Hon'ble CAT, Cuttack Bench, Cuttack.

The order dated 22.11.2019 of the Hon'ble Tribunal is as follows:-

"The OA is disposed of at this stage with a direction to the respondent No.2 to consider the representation of the applicant filed at Annexure A/8 series after taking into account the circular dated 30.05.2017 (Annexure- A/7) and other circular/rules as applicable to the applicant's case and disposed of the said representation by passing a speaking order, copy of which is to be communicated to the applicant within a period of 3 months from the date of receipt of a copy of this order."

In the light of the above directions of the Hon,ble CAT, Cuttack Bench, Cuttack, the committee re-examined the case of **Rajat Kumar Mahanta**, S/o Late Dambarudhar Mahanta who is having the minimum prescribed educational qualification and within the age limit. Hence the Committee **Recommended** his engagement against any vacant post of GDS under Keonjhar Division

(45) The case of **Abanikanta Behera**, S/o Late Parikihita Behera, Ex-GDSMD-II Asurali SO under Bhadrak Division was considered in the CRC held on 24.11.2010 and rejected by the CRC as his family was not found to be in indigent condition.

Being aggrieved by the decision, the applicant filed OA No. 358/2011 before the Hon'ble CAT, Cuttack Bench, Cuttack. The Hon'ble CAT, directed to consider the case of applicant twice more on availability of vacancy under compassionate quota. Accordingly the case of the applicant was put up before the CRC met on 30.07.2013 for reconsideration and the case was rejected as the case was not considered hard and deserving as defined in Directorate letter No. 17-17/2010-GDS dated 14.12.2010 and 09.03.2012.

As per the order of the Hon'ble CAT, the case of the applicant was again put up before CRC held on 06.12.2013 and could not be recommended as he secured less than 51 merit points in the 100-point scale to consider the case as hard and deserving.

Being aggrieved, the applicant filed 474/2014 in the Hon'ble CAT, Cuttack Bench, Cuttack. Now the order of the Hon'ble Tribunal dated 10.01.2020 is as follows:

"The respondent No. 2 is directed to reconsider the case of the applicant one more time in the light of the circular dated 30.05.2017, by which the point system for examining the case of compassionate appointment for GDS has been dispensed with, treating the applicant's case to be not finalized & settled, and take a decision in the matter by communicating a speaking order to the applicant within four months from the date of receipt of a copy of this order".


In the light of the above directions of the Hon,ble CAT, Cuttack Bench, Cuttack, the committee re-examined the case of **Abanikanta Behera**, S/o Late Parikihita Behera who is having the minimum prescribed educational qualification and within the age limit. Hence the Committee **Recommended** his engagement against any vacant post of GDS under Bhadrak Division

The selection of candidates for engagement of the dependents of GDS are subject to the following conditions:

1. No material fact that would adversely affect their selection on relaxation ground is suppressed by the candidates in the synopsis submitted by them.
2. The selection can be cancelled at any time if any error is detected in the information supplied by them which has aided their selection.
3. If any error is detected after the candidate is engaged as GDS on relaxation ground, the engagement will be terminated forthwith.
4. The candidates on their engagement as GDS will take care of the family members of the deceased GDS. A declaration to this effect has to be obtained and kept on record.
5. The approved candidates will submit required certificates on basic computer training before their engagement to the concerned units.

N.B : The recommended candidates may be engaged as BPMs/ ABPMs/Dak Sevaks as per instructions contained in Para -2 of the Directorate letter No. 17-31/2016-GDS dated 25.06.2018.

It is requested to communicate the decision of the committee to the above candidates and take further necessary action at your end for engagement of the above candidates selected for GDS following usual formalities within a fortnight and report compliance.
