



The above transfer is subject to the following terms and conditions:-

- i. The maximum number of chances to be provided for male GDS shall be two chances and three chances for female GDS in entire term of engagement.
- ii. Refused to accept the Limited Transfer order shall be construed as one chance of Limited Transfer availed by GDS.
- iii. Transfer of GDS who are under put off duty or against whom any disciplinary action, police case or court case is pending but approved for transfer under LTF Scheme is liable to be cancelled.
- iv. Above transfer is subject to satisfactory completion of verification of all educational and caste certificates submitted by the GDS at the time of engagement.
- v. Past engagement will be counted for assessing the eligibility for appearing departmental examination as well as for annual increments.
- vi. GDS transferred under LTF will not have any claim to go back to the previous engagement/recruitment Unit/Division. However, this could not act as a bar for applying to the old post/old unit under the provisions of Directorate OM No.17-31/2016-GDS dated 15.07.2021.
- vii. When a GDS is transferred at his her own, she/he will rank junior in the seniority list of new unit, to all GDS of that unit who exist in the seniority list on the date on which he/she joins the new unit except in case of transfer in the same engagement/recruitment Sub-Division/Unit/Division.
- viii. There will not be any drop in TRCA on account of a request transfer and number of increments earned by GDS will be retained.
- ix. ABPM Level II transferred as BPM Level I in same TRCA Slab, has to make accommodation arrangement for managing BO as per standard prescribed for BO and fulfilling the condition of educational qualification, computer certificate etc. Prescribed by the Departmental from time to time. Before joining as BPM Level I, he/she has to undergo prescribed training for BPM.
- x. Transfer has been considered in order of date of application, date of engagement and date of birth of GDS as outlined in Directorate OM No.17-31/2016-GDS dated 15.07.2021.
