Part -IV

The Committee on Compassionate Engagement (CCE) considered the following Court/CAT case of the dependents of the deceased GDSs for their engagement on compassionate ground.

(32) The case of the **Ramesh Chandra Mohanta**, S/o Late Maheswar Mohanta, Ex-GDSMC, Betnoti SO under Mayurbhanj Division considered in the CRC held on 24-11-2010 and rejected as the family of the deceased was found not to be in indigent condition.

The applicant has filed OA No. 09/2012 before the Hon'ble CAT, Cuttack Bench, Cuttack against the decision of the CRC.

The Hon'ble Tribunal vide order dated 03.07.2018 has directed to the Respondent to re-open the case and ask the applicant to submit his application in the context of the merit point system and his case should be considered for two more years in the next CRC meeting.

The committee examined the case in the light of the Hon'ble Tribunal vide order dated 03.07.2018 in the CCE meeting held on 11 Jun 2019, 02 Sep 2019 and 18.11.2019, 21.02.2020, 26.05.2020, 29.07.2020 and 28.09.2020 and did not approve the case due to less educational qualification and over aged as the applicant is 62 years old.

Again as per the direction of the Hon'ble Tribunal the case was re-examined and **did not recommend** the case due to less educational qualification and over aged as the applicant is 62 years old.

The selection of candidates in **Part-I** for engagement of the dependents of GDS are subject to the following conditions:

1. No material fact that would adversely affect their selection on relaxation ground is suppressed by the candidates in the synopsis submitted by them.
2. The selection can be cancelled at any time if any error is detected in the information supplied by them which has aided their selection.
3. If any error is detected after the candidate is engaged as GDS on relaxation ground, the engagement will be terminated forthwith.
4. The candidates on their engagement as GDS will take care of the family members of the deceased GDS. A declaration to this effect has to be obtained and kept on record.
5. The approved candidates will submit required certificates on basic computer training before their engagement to the concerned units.
6. The engagement of the candidates is subject to satisfactory verification of the certificates/documents submitted by the applicant.
